CERTIFICATE REQUIREMENTS

- Students must complete 4.244J/11.333J Urban Design Seminar to obtain the certificate.
- If a student does not have a prior professional degree in architecture, landscape architecture, or urban design, that student is required to take 4.240J/11.328J Urban Design Skills and 4.248J/11.329J Advanced Urban Design Skills.
- Students must take at least one subject in each category, and at least one subject from one of these categories must be at an advanced level (* signifies advanced level course).
- Substitutions of subjects should be approved in advance by an Urban Design Committee member. Required subjects may not be substituted. A maximum of one substitution is permitted. Please ask your academic administrator for a substitution form and discuss with academic administrator if you have questions.
- Students in MCP degree who complete the Urban Design Certificate are not required to take a separate practicum course. In other words, completing the Urban Design Certificate constitutes a fulfillment of the practicum requirement (note that certificate must be completed to receive this credit.)
- All courses must be taken for credit and receive a letter grade (e.g. no P/F, no audit).
